CERTIFICATE OF INCORPORATION

OF

We, the undersigned, in order to form a Corporation for the purposes hereinafter stated, under and pursuant to the provisions of an Act of the legislature of the State of Florida approved June 1, 1925, and the acts amendatory thereto, do hereby subscribe to this Certificate of Incorporation.

FIRST:

The name of the Corporation is

SECOND: The general nature of the business to be transacted by the corporation is as follows: To act as distributors of Caribbean products, meat products, and other food products. To act as general traders and internet traders of goods and merchandise. To import and export goods and merchandise. To provide export and cargo consolidation services. To manufacture, purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign, and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise, and other personal and real property of every class and description whatsoever.

To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said business or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitably dealt with in connection with any of the said business.
