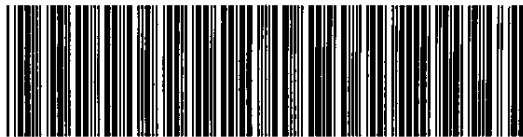

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a Corporation under the Florida "Professional Services Act, Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation of such Corporation.

ARTICLE I.

The name of the Corporation shall be:

Surgical Associates of Tallahassee, P.A.

ARTICLE II.

The address of the principal place of business of this corporation shall be 1405 Centerville Rd, Suite 4400, Tallahassee, Florida 32308 and the mailing address of the Corporation shall be the same.

ARTICLE III.

The purpose for which the Corporation is organized is to engage in the practice of medicine and all other lawful business activity permitted under the laws of the United States of America and the State of Florida.

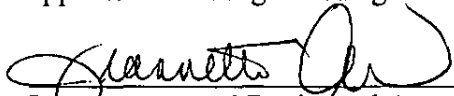
