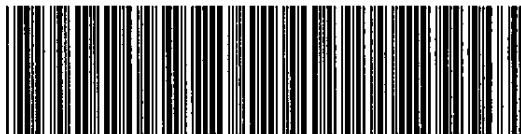



ARTICLES OF INCORPORATION OF

INTELL INSTITUTE, INC.

ARTICLE I Name of Corporation

The name of this corporation is INTELL INSTITUTE, INC.

ARTICLE II Purpose

Incorporated primarily as a provider of educational services, INTELL INSTITUTE, INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV Corporate existence and Date of Operation

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.






