**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF LORSIM, INC.**

Pursuant to the provisions of Sections 607.1005 and 607.1006 of the Florida Statutes, LORSIM, INC., a Florida for profit corporation (the "Corporation"), filed on September 30, 2015, Document Number P15000080858, adopted the following amendments to its Articles of Incorporation:

1. **Article VII** of the Articles of Incorporation of this Corporation is hereby deleted in its entirety and replaced by the following:

**ARTICLE VII**

The Corporation shall have one (1) or more directors. The number of directors may either be increased or diminished from time to time by the By-Laws but shall never be less than one (1).

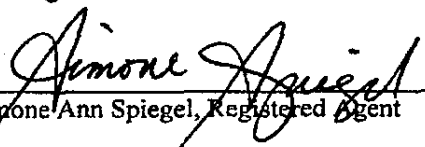
2. **Article VIII** of the Articles of Incorporation of this Corporation is hereby deleted in its entirety, and replaced by the following:

3. The date of each amendment's adoption was as of September 30, 2015.

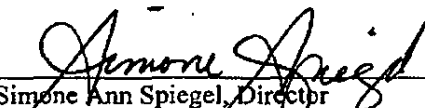

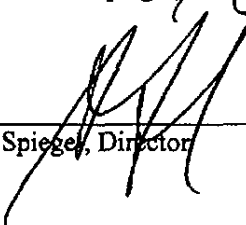
