**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
AERO MACH PARTS & SERVICES, CORP.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), Aero Mach Parts & Services, Corp., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:
