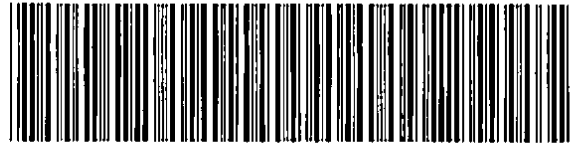

**SECOND AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
ENVISION PHYSICIAN SCIENTIFIC INTELLIGENCE, INC.**

Pursuant to the provisions of Section 607, Florida Statutes, Envision Physician Scientific Intelligence, Inc., a Florida corporation (the "Corporation"), certifies the following:

1. The Articles of Incorporation was incorporated on October 6, 2015 and assigned Document No. P15000083197 under the name Sheridan Scientific Intelligence, Inc.
2. Articles of Amendment to the Corporation's Articles of Incorporation were filed on December 12, 2017 changing the name of the Corporation to Envision Physician Scientific Intelligence, Inc.
3. This Second Amendment to the Articles of Incorporation (the "Second Amendment") of the Corporation are to be deleted in its entirety and replaced by the following:

"ARTICLE 1 – NAME

The name of the corporation shall be ENVISION HEALTHCARE SCIENTIFIC INTELLIGENCE, INC. (the "Corporation")."

4. The Second Amendment was adopted by the sole director and sole shareholder of the Corporation as of March 18, 2019 in the manner prescribed by law.
5. Except as amended hereby, all other provisions of the Articles of Incorporation remain in full effect as of the date hereof.
6. The foregoing Second Amendment to the Articles of Incorporation of the Corporation shall be effective upon filing among the records of the Florida Department of State, Division of Corporations.
