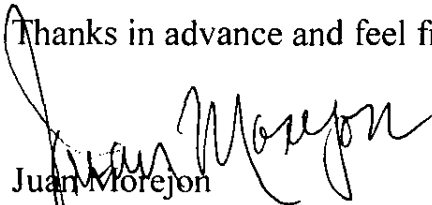

Of

We, the undersigned, hereby associate ourselves together for the Purpose of becoming a corporation under laws of State of Florida Provinding for the formacion, rights,privileges,immunities,and Liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

ARTICLE II

The corporation will engage in any activity or business permitted under the laws of the State of Florida and the United States of America.

And has the FEIN # 27-3001708

ARTICLE III

The maximun number of shares which the corporation is authorized to issue and have outstanding at any one time, is 500 shares of common stock, one dollar(\$1.00) par value.

All stock is to be issued as fully paid and exempt from assessment.

ARTICLE IV

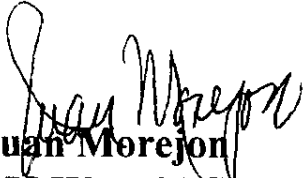
