### ARTICLES OF INCORPORATION

OF

### EXODUS ENTERPRISES OF BREVARD, INC.

## ARTICLE I - NAME

The name of the corporation is Exodus Enterprises of Brevard, Inc., at 598 Borraclough Avenue NW, Palm Bay, FL 32907(Principal Office of Registered Agent).

### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any of all lawful business.

### ARTICLE IV - CAPITAL STOCK
