ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of RAFFAELE QUATTROCCHI, PA under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

ARTICLE X. AMENDMENTS

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on share-holders are subject to this reservation.
