**AMENDED AND RESTATED  
ARTICLES OF INCORPORATION OF  
INTERNET FINANCIAL SERVICES STANDARD COMMITTEE CORPORATION,  
a Florida corporation**

(Pursuant to Sections 607.1001, 607.1003, 607.1006 and 607.1007 of the Florida Business Corporation Act  
(the "Act"))

**INTERNET FINANCIAL SERVICES STANDARD COMMITTEE  
CORPORATION**, a corporation organized and existing under and by virtue of the provisions of  
the Act,

**DOES HEREBY CERTIFY:**

1. That the name of this corporation is **INTERNET FINANCIAL SERVICES  
STANDARD COMMITTEE CORPORATION**, and that this corporation was originally  
incorporated pursuant to the Act on October 19, 2015 and assigned document number  
P15000085990.

2. That the Board of Directors recommended and the Shareholders duly adopted a  
resolution proposing to amend and restate the Articles of Incorporation of this corporation,  
declaring said amendment and restatement to be advisable and in the best interests of this  
corporation and its stockholders, and authorizing the appropriate officers of this corporation to  
solicit the consent of the stockholders therefor, which resolution setting forth the proposed  
amendment and restatement is as follows:

**RESOLVED**, that the Articles of Incorporation of this corporation be amended and  
restated in its entirety to read as follows:

**ARTICLE ONE:**  
**NAME**

The name of this corporation is **INTERNATIONAL FINANCIAL SERVICES  
STANDARD COMMITTEE CORPORATION**.

**ARTICLE TWO:**  
**PRINCIPAL OFFICE**

The street address of the principal office and mailing address of the Corporation is 1802  
North Alafaya Trail, Orlando, Florida 32826.

**ARTICLE THREE:**  
**REGISTERED OFFICE AND AGENT**

The mailing address and street address of the registered office of the Corporation are One  
Independent Drive, Suite 1300, Jacksonville, Florida 32202. The name of the registered agent of  
the Corporation is F & L Corp.

**ARTICLE FOUR:**  
**DURATION**

The term of existence of the Corporation shall be perpetual.

**ARTICLE FIVE:**  
**PURPOSE**

The Corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

**ARTICLE SIX:**  
**CAPITAL STOCK**

The Corporation shall have authority to issue ONE HUNDRED (100) shares of Common Stock having (\$.01) par value per share.

**ARTICLE SEVEN**  
**BYLAWS**

The Board of Directors of the Corporation is expressly empowered to adopt, amend or repeal the Bylaws of the Corporation.

**ARTICLE EIGHT**  
**INDEMNIFICATION**

A. **Indemnification.** To the fullest extent permitted by applicable law, the Corporation is authorized to provide indemnification of (and advancement of expenses to) directors, officers, employees and agents of the Corporation (and any other persons to which the Act permits the Corporation to provide indemnification) through Bylaw provisions, agreements with such agents or other persons, vote of stockholders or disinterested directors or otherwise, in excess of the indemnification and advancement otherwise permitted by Section 607.0850 of the Act.

B. **Insurance.** The Corporation may, to the fullest extent permitted by applicable law, at any time without further stockholder approval, purchase and maintain insurance on behalf of any person who is or was a director, officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise against any liability asserted against such person and incurred by such person in any such capacity, or arising out of such person's status as such, whether or not the Corporation would have the power to indemnify such person against such liability under applicable law.

C. **Limitation of Director Liability.** The personal liability of the directors of the Corporation for monetary damages shall be eliminated to the fullest extent under applicable law. If the Act is amended to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by the Act, as so amended.




