I, the undersigned, do hereby form the above corporation and to that end do hereby certify to the facts hereinafter set forth, as required by law.

The name of the proposed corporation shall be:

G & H Field Services, Inc.

The general nature of the business to be transacted is as follows, to-wit:

- Primary purpose will be residential and commercial building and land restoration services
 and related business.
- To purchase or otherwise acquire and to hold and to own or to sell, assign, transfer, mortgage, pledge or otherwise dispose of real or personal property which the corporation might own or hold.
- 3.
