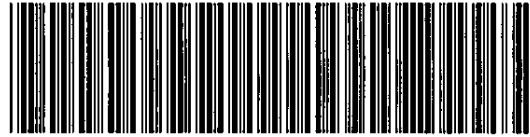

**ARTICLES OF INCORPORATION  
OF  
YOUR PET SOURCE, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I- NAME**

The name of the Corporation is: YOUR PET SOURCE, INC..

**ARTICLE II - NATURE OF BUSINESS**

This corporation may engage in any and all lawful activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III - BEGINNING OF CORPORATE EXISTENCE**

The existence of the Corporation shall begin on: October 09, 2015.

**ARTICLE IV- PRINCIPAL ADDRESS**

The street address of the principal office of the Corporation is: 1110 West Pine Ridge Circle, Brandon, Florida 33511.

**ARTICLE V - CAPITAL STOCK**

The maximum number of shares this Corporation is authorized to issue is 7500, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

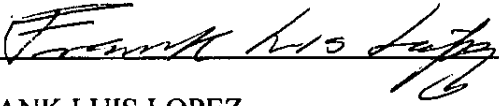
**ARTICLE IX - INDEMNIFICATION**

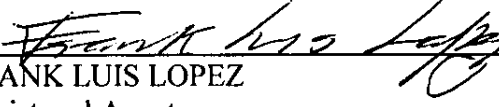
