ARTICLES OF AMENDMENT AND RESTATEMENT

1. The name of this Corporation is LASERIQ PAIN THERAPY, INC. The document number is P15000087796.

2. The Articles of Incorporation, as amended and restated, are set forth on Annex A attached hereto (the "Amended and Restated Articles").

3. The Amended and Restated Articles contain amendments to the Articles of Incorporation requiring shareholder approval.

4. The amendments to, and restatement of, the Articles of Incorporation included in the Amended and Restated Articles, were adopted by the Board of Directors and approved by the shareholders pursuant to Joint Action by Written Consent of the Shareholders and Directors executed on October 30, 2015, as permitted by Sections 607.0704, 607.0821 and 607.1003 of the Florida Statutes.

5. The sole voting group entitled to vote on this amendment is comprised of the holders of common stock, and the number of votes cast for the amendment by such voting group was sufficient for approval by that voting group.

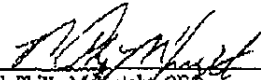

ARTICLES OF INCORPORATION OF

The Amended and Restated Articles of Incorporation of LASERIQ PAIN THERAPY, INC. shall read in their entirety as follows:

**ARTICLE I**

**Name**

The name of this corporation is:

This corporation shall have perpetual existence.

**ARTICLE III**

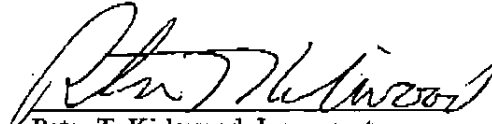

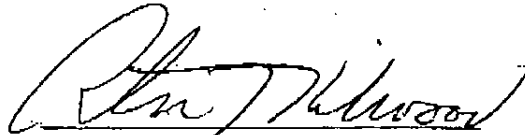
