# ARTICLES OF INCORPORATION OF GLEN MILLER REALTY, INC.

The undersigned incorporator executes and adopts the following Articles of Incorporation for the Corporation:

#### ARTICLE 1.

1.1 <u>Name and Address.</u> The name of the Corporation is Glen Miller Realty, Inc., and the mailing address of the Corporation is 1815 SW 34<sup>th</sup> Court, Ocala, FL 34474. The address of the Corporation's principal office is 1815 SW 34<sup>th</sup> Court, Ocala, FL 34474.

#### ARTICLE 2.

2.1 <u>Duration</u>. The period of duration of the Corporation is perpetual.

#### ARTICLE 3.

- 3.1 <u>Purpose</u>.
