**ARTICLE I.
NAME**

The name of this corporation is: Orest M Krajnyk MD PA

**ARTICLE II.
DURATION**

The duration of this corporation is perpetual.

**ARTICLE III.
GENERAL PURPOSES**

The purposes for which this corporation is initially organized are to engage in every phase and aspect of an ophthalmology practice, rendering the same professional services to the public that a medical doctor, duly licensed under Florida law is authorized to render, but such services will be rendered only through the corporation's officers, employees, and agents who are duly authorized under Florida law as a medical doctor. The corporation also may engage in any or all lawful business which professional service corporations practicing law may engage in under the Florida Professional Service Corporation and Limited Liability Company Act.

**ARTICLE IV.
SHARES**

The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common voting stock having a par value of \$1.00 per share.

**ARTICLE V.
PRINCIPLE OFFICE AND REGISTERED AGENT**

The street address and mailing address of the principle office of the corporation is 2568 S. Ridgewood Avenue, Suite 4, Edgewater, Florida 32141. DISQUALIFICATION OF SHAREHOLDERS, OFFICERS, AGENTS AND
EMPLOYEES**

If any officer, stockholder, agent or employee of this corporation who has been rendering professional medical services to the public, becomes legally disqualified to render such services within the State or accepts employment which, pursuant to existing laws, places restrictions or limitations upon his or her continued rendering of such professional services, he or she shall sever all employment with, and financial interest in, this corporation forthwith.

**ARTICLE IX.
VOTING TRUSTS**

No shareholder of this corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his or her shares.

**ARTICLE X.
STOCKHOLDERS**

Shares of this corporation's capital stock shall be issued only to individuals who are duly licensed to render services as a medical doctor under the laws of the State of Florida, or to professional corporations or professional limited liability companies legally authorized under the laws of the State of Florida to render professional dental services.


**ARTICLE XI.


