Fundize, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 140,000 of which 100,000 shares of par value \$0.001 per share shall be designated as Common Stock and 40,000 shares of par value \$0.001 shall be designated as Preferred Stock.
