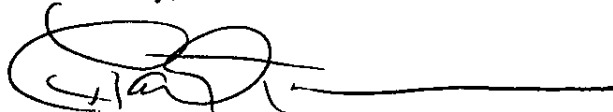

ARTICLE I

Name of Corporation

The name of this corporation is RIVER EQUITY INC.

ARTICLE II

Purpose

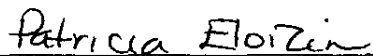
