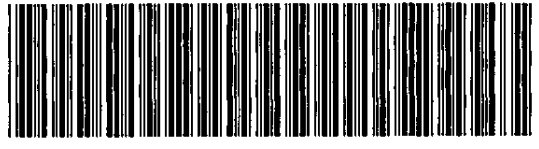



ARTICLES OF INCORPORATION

In compliance with Chapter 607, Florida Statutes, the undersigned subscriber, a natural person acting as Incorporator for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of the Corporation shall be

KILLAWATT CORP.

ARTICLE TWO - PRINCIPAL OFFICE

ARTICLE THREE - PURPOSE AND DURATION

The Purpose for which the Corporation is organized is to engage in and transact any and all lawful business for which corporations may be permitted under the laws of the State of Florida and in all other States and Countries. The term of its existence shall be perpetual and shall commence effective upon issuance receipted by the State of Florida or on the first day of October, 2015.

ARTICLE FOUR - CAPITAL STOCK

The Corporation shall be authorized to issue up to One Thousand shares of common stock, having a par value of One Dollar per share. One Hundred shares shall be issued initially, with the remainder held in the Corporation's treasury. 


