



**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of the corporation in compliance with Chapter 607 and/or Chapter 621, Florida Statutes (Profit), hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I.**  
**NAME**

**ARTICLE II.**  
**DURATION**

This corporation shall have perpetual existence.

**ARTICLE III.**  
**PRINCIPAL OFFICE**

**ARTICLE IV.**  
**PURPOSE**

The purpose for which the corporation is organized is for engineering and engineering related services and consulting and for any other lawful purpose and to do everything necessary, proper, advisable or convenient for the accomplishment of said purposes, and to do all things incidental to them or connected with them

An affirmative vote of the majority of the shares of the corporation shall be required for any shareholder action, unless otherwise set forth in the By-laws.


**ARTICLE IX.**

**PREEMPTIVE RIGHTS**






