**ARTICLES OF INCORPORATION  
OF  
DADE CRITICAL CARE, P.A.**

Pursuant to the provisions of the Florida Business Corporation Act (Chapter 607, Florida Statutes) and the Professional Service Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes), the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

**ARTICLE I - NAME**

The name of the corporation is Dade Critical Care, P.A. (the "Corporation")

**ARTICLE II - ADDRESS**

The principal office address and the mailing address of the Corporation is 1400 N.W. 12<sup>th</sup> Avenue, Suite 1, Miami, Florida 33136.

**ARTICLE III - CAPITAL STOCK**

The Corporation is authorized to issue 1,000 shares of common stock, par value \$0.01 per share.

**ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT**

The address of the registered office of the Corporation is 1400 N.W. 12<sup>th</sup> Avenue, Suite 1, Miami, Florida 33136. The name of the registered agent of the Corporation at such address is Alejandro Vilasuso.

**ARTICLE V - INCORPORATOR**

**ARTICLE VI - NATURE OF BUSINESS**


The general nature of the business to be transacted by the Corporation shall be to engage in consulting related to the practice of medicine. The professional services involved in the Corporation's consulting related to the practice of medicine may be rendered only through its officer, employees and agents who are duly authorized and licensed to practice medicine in the State of Florida. The Corporation shall not engage in any business other than that related to the medical profession; provided, however, that the Corporation may invest its funds in real estate, mortgages, stock, bonds or other types of investments and may own real and personal property necessary for the rendering of the professional services authorized hereby.


