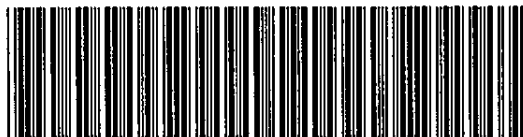

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of THE MIGLIORI LAW FIRM, P.A. under the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is THE MIGLIORI LAW FIRM, P.A. (the "Corporation").

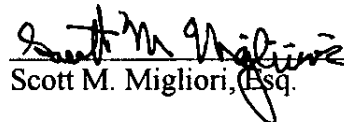
