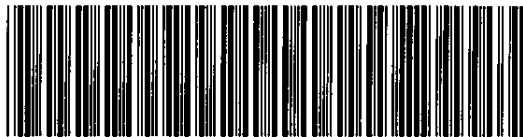

**ARTICLES OF INCORPORATION
OF

ARTICLE ONE

The name of the corporation is GUITAR PLAYER ENTERPRISES, INC.



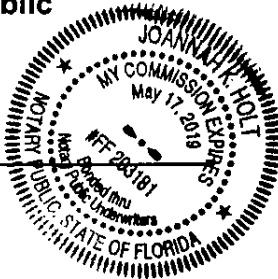
