ARTICLE I - NAME

The name of the Corporation (the "Corporation") is **COFE AVENTURA CORP.**

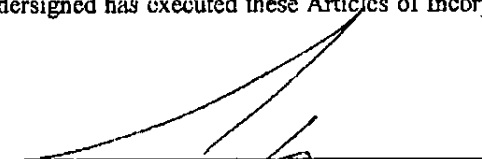
ARTICLE VIII - INDEMNIFICATION


