**ARTICLES OF INCORPORATION
OF
PRO-LINK GLOBAL GROUP 5 CORP.**

The undersigned, acting as the Incorporator of Pro-Link Global Group 5 Corp., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME
