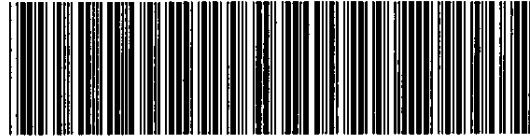

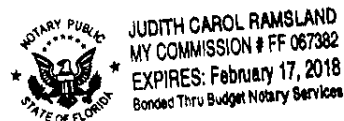
1. Introduction. Tynette Chandler, being duly sworn, deposes and says:
