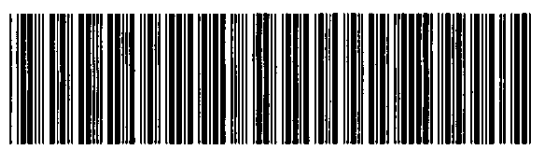

Articles of Incorporation

of

Midland IRA, Inc.

A Florida Corporation

The undersigned incorporator to these Articles of Incorporation hereby adopts and files the following articles of incorporation to form a corporation (the "Corporation") under Chapter 607 of the Florida Statutes.

1. Name

The name of the Corporation is Midland IRA, Inc. The Corporation's principal office (and mailing address) is located at 1520 Royal Palm Square Boulevard, Suite 320, Fort Myers, Florida 33919 in Lee County, Florida.

2. Nature of Business

The Corporation is formed to engage in the business of providing administrative services and to engage or transact in any or all other lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other state, country, territory or nation.

3. Capital Structure

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock having par value of one hundred dollars (\$100.00) per share.

4. Incorporator

5. Initial Registered Office and Agent

6. Board of Directors

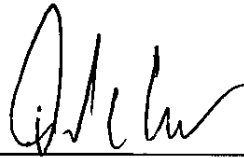
The affairs of the Corporation shall be managed by a Board of Directors, members of which shall be elected in accordance with bylaws adopted for the

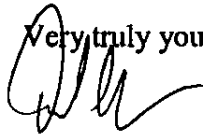
