**ARTICLES OF INCORPORATION  
OF  
SEFIRA MAITLAND US HOLDING INC.**

**ARTICLE I – CORPORATE NAME**

The corporate name for the corporation is SEFIRA MAITLAND US HOLDING INC.  
(the "Corporation").

**ARTICLE II – STREET ADDRESS**

The street address of the initial principal office and the mailing address of the Corporation are:

**ARTICLE III – CAPITAL STOCK; NUMBER OF SHARES; VOTING**




