

ARTICLES OF INCORPORATION OF DURBIN MANAGEMENT COMPANY, INC.

The undersigned, for the purpose of forming a corporation under Florida General Corporation

Act, hereby adopts the following articles of incorporation:

ARTICLE I

The name of this corporation shall be **DURBIN MANAGEMENT COMPANY**, **INC.**, hereinafter referred to as the "corporation."
