**ARTICLE I**  
**NAME OF CORPORATION**

The name of the corporation shall be:

**CAPITAL STOCK**

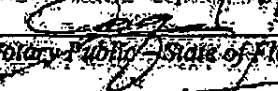

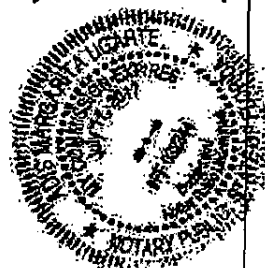
