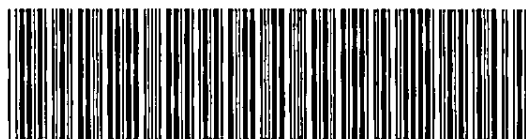

Article III is hereby deleted in its entirety and replaced with the following:

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 2,000 shares of common stock, each having \$1.00 par value. The consideration to be paid for each share shall be fixed by the Board of Directors and any and all shares so issued, the full consideration for which has been paid or delivered, shall be deemed full paid stock and not liable to any further call or assessment thereon; and the holders of such shares shall not be liable for any further payments thereon. The capital stock may be paid for in property, labor or services at a just valuation to be fixed by the incorporators or the Directors. The stock shall be issued from time to time as may be determined by the Board of Directors. On dissolution or liquidation of the corporation, the holders of the stock shall be entitled to distribution as their holdings may appear upon the stock record of the corporation.
