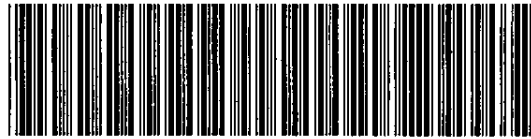

Article I. The name of the corporation is: JLMRPO, Inc.

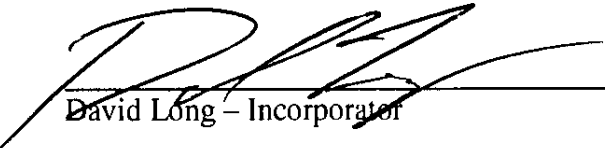
