

ARTICLES OF INCORPORATION OF SERIES X HOLDING COMPANY

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Series X Holding Company, and its principal office and mailing address is 5350 W. Kennedy Blvd., Suite Two, Tampa, Florida 33609.

Commencement and Term of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State. This Corporation shall have perpetual existence.
