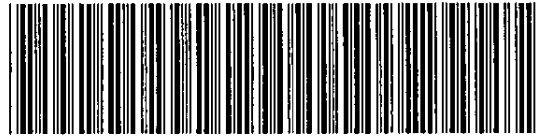

ARTICLE I – NAME



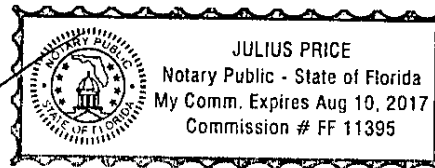

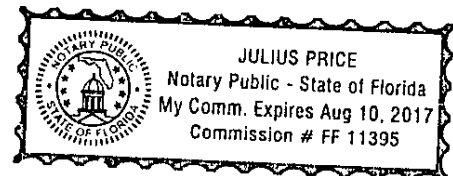
