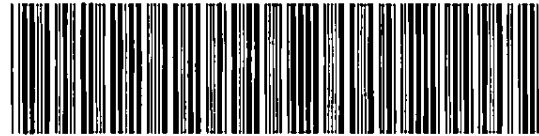

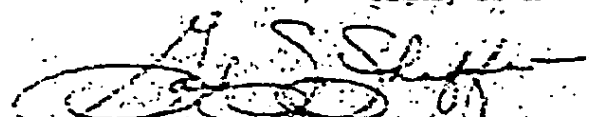

ARTICLES OF MERGER
of
PEOPLES TELEPHONE COMPANY, a Florida corporation
with and into
TTI INDUSTRIES, INC., a New York corporation

Pursuant to Section 607.234 of the Florida General Corporation Act, PEOPLES TELEPHONE COMPANY, a Florida corporation ("PTC"), and TTI INDUSTRIES, INC., a New York corporation ("TTI"), hereby adopt the following Articles of Merger for the purpose of merging PTC into TTI (the "Merger"):

FIRST: The surviving corporation of the Merger shall be TTI.

SECOND: Pursuant to the Agreement and Plan of Merger, upon the effectiveness of the Merger, the certificate of incorporation of TTI shall be and remain the certificate of incorporation of the surviving corporation, except for the following amendments:

Paragraph **FIRST** is amended in its entirety to read as follows:

FIRST: The name of the corporation is: Peoples Telephone Company.

Paragraph **FOURTH** is amended in its entirety to read as follows:

FOURTH: Capital Stock. The total number of shares of all classes of capital stock which the corporation shall have the authority to issue and have outstanding is 15,000,000, of which 10,000,000 shall be Common Stock, par value \$0.01 per share, and 5,000,000 shall be Preferred Stock, par value \$0.01 per share. The shares may be issued from time to time as authorized by the Board of Directors without further approval of shareholders. The consideration for the issuance of the shares shall be paid in full before their issuance and shall not be less than the par value. Future services shall not constitute payment or part payment for the issuance of shares of the corporation. The consideration for the issuance of the shares shall not be less than the par value. Future services shall not constitute payment or part payment for the issuance of shares of the corporation. The consideration for the shares shall be cash, tangible or intangible property, labor or services actually performed for the corporation, or any combination of the foregoing. In the absence of actual fraud in the transaction, the value of such

property, labor or services as determined by the Board of Directors of the Company, shall be conclusive. Upon payment of such consideration, such shares shall be deemed to be fully paid and nonassessable.

A. Common Stock. Each share of Common Stock shall have the same relative rights as and be identical in all respects with all the other shares of Common Stock.

B. Preferred Stock. The Preferred Stock may be issued in series by the board of directors from time to time, each series with such dividend rights, voting rights, liquidation preferences, redemption rights, conversion rights and other rights and preferences as the Board of Directors may from time to time provide, as authorized by applicable laws.

Paragraph TENTH is added and shall read as follows:

TENTH: The officers and directors of the Corporation shall be indemnified to the fullest extent provided by law. The right to indemnification and advancement of expenses as otherwise provided by law shall not be exclusive of any other right which any officer or director may have or hereafter acquire under any provision of the corporation's Certificate of Incorporation or By-Law or by any agreement, vote of shareholders or disinterested directors of the Company or otherwise, provided that no indemnification may be made to or on behalf of any officer or director if a judgment or other final adjudication adverse to the officer or director establishes that his acts were committed in bad faith or were the result of active and deliberate dishonesty and were material to the cause of action so adjudicated, or that he personally gained in fact a financial profit or other advantage to which he was not legally entitled.

THIRD: The terms and conditions of the merger transaction as set forth in these Articles of Merger were authorized and approved by the Board of Directors and shareholders of PTC in the manner and by the vote required by its articles of incorporation and the laws of the State of Florida, the state of its incorporation, by a unanimous written consent of directors, dated as of April 10, 1987, and by a written consent of a majority of shareholders, dated as of May 4, 1987, all in accordance with the Florida General Corporation Act.

The terms and conditions of the merger transaction as set forth in these Articles of Merger were authorized and approved by the Board of Directors and shareholders of TTI in the

manner and by the vote required by its certificate of incorporation and the laws of the State of New York, the state of its incorporation, by a unanimous written consent of directors, dated as of April 10, 1987, and at the Company's annual meeting of shareholders held on May 29, 1987, by a two-thirds vote of the shareholders of TTI entitled to vote at that meeting, all in accordance with the New York Business Corporation Law.

FOURTH: Each share of common stock of TTI which is issued and outstanding immediately prior to the effective date of the Merger shall, by virtue of the Merger and without any action on the part of the holder thereof, be converted into and represent the right to receive one-tenth of a share of common stock of TTI, the surviving corporation, with cash to be paid in lieu of issuance of fractional shares.

Each share of common stock of PTC which is issued and outstanding immediately prior to the effective date of the Merger, shall by virtue of the Merger and without any action on the part of the holder thereof, be converted into and represent the right to receive one share of common stock, par value \$.01 per share, of TTI, the surviving corporation.

FIFTH: The Merger shall become effective when the Department of State of the State of New York files the certificate of merger in accordance with the New York Business Corporation Law.

SIXTH: Dissenting shareholders shall be entitled to the rights of dissenting shareholders as provided for in Section 607.244 of the Florida General Corporation Act.

IN WITNESS WHEREOF, PTC and TTI have caused these Articles of Merger to be signed in their respective corporate names and on their behalf by their respective presidents and their respective secretaries, as of the 10th day of June, 1987.

Pursuant to Section 607.234 of the Florida General Corporation Act, PEOPLES TELEPHONE COMPANY, INC. a New York corporation ("PTC"), PEOPLES TELEPHONE COMPANY OF SOUTH CAROLINA, INC. ("PTCSC") and PEOPLES TELEPHONE COMPANY OF VIRGINIA, INC. ("PTCVA"), hereby adopt the following Articles of Merger:

(a) PTCSC and PTCVA hereby merge with and into PTC (the "Merger") and PTC shall be the surviving corporation.
