Your assistance and cooperation in this matter would be greatly appreciated.

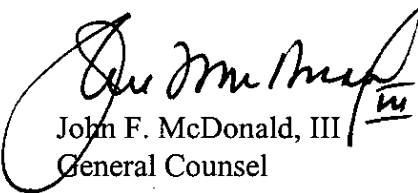
