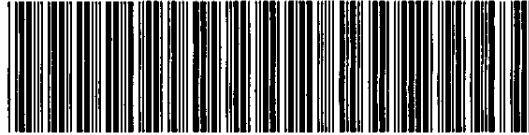

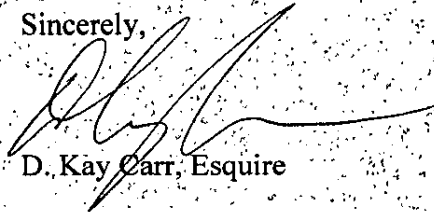

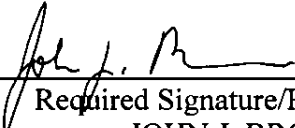
ARTICLE VIII

Effective date will be the date of filing.

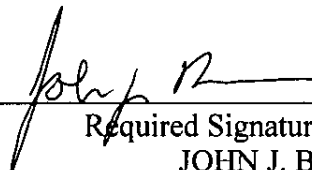
