**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Harper Legal, P.A., under the Florida Business Corporation Act, Florida Statutes Chapter 607 (the "Business Corporation Act"), and the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes Chapter 621 (the "Professional Service Corporation Act"), hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

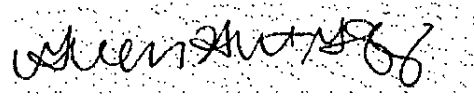

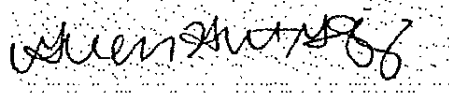
