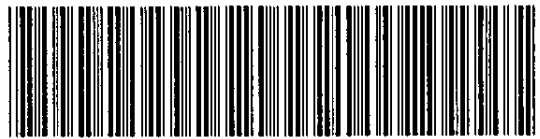

**ARTICLES OF INCORPORATION**

**ARTICLE I**

The name of the corporation is NELSON M. PICHARDO HOLDINGS, INC. (hereinafter called the "Corporation").

**ARTICLE II**
