Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, pursuant to a consent meeting of all the Shareholders and members of the Board of Directors effective September 20, 2024.

1. The date of filing the Articles of Incorporation was January 8, 2016, and Florida Document Number P16000002044 was assigned to such filing.

2. Articles of Amendment to the Articles of Incorporation were previously filed and accepted on May 3, 2019.

3. Article XIII is hereby added to the Articles of Incorporation as follows:

**"Article XIII"**


Gregory Balotin, 3740 St. Johns Bluff Rd., Suite 21, Jacksonville, FL 32224 shall serve as President of the Corporation; and
