**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is AMERICAN PARTNER SOLUTIONS, INC., and the principal address and principal place of business is 9427 Corporate Lake Drive, Tampa, Florida 33634.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI - AMENDMENTS

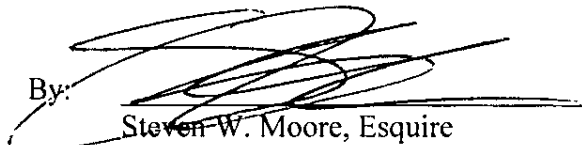

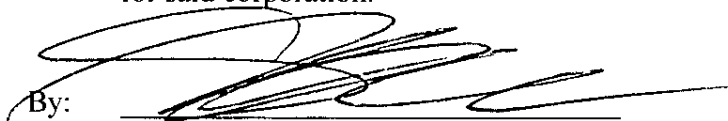
