## PLAN OF MERGER

COME now LAVETI, INC., and ADITYA PROPERTIES, LLC, and they hereby enter into this plan of merger and agree:

1. Laveti, Inc., hereinafter called "Laveti", is a for profit corporation formed in the State of Florida.
2. Aditya Properties, LLC, hereinafter called "Aditya", is a Limited Liability Company formed in the State of Florida.
3. Aditya is merging into Laveti. Aditya will be dissolved. Laveti, Inc., a Florida for profit corporation, will be the survivor.
4. Chandrashekar Laveti and Soujanya Chalumuri, husband and wife, are the sole stockholders of Laveti; and are also the sole members of Aditya.
5. After the merger Chandrashekar Laveti and Soujanya Chalumuri, husband and wife, will continue to own one hundred percent (100%) of the issued and outstanding shares of stock of Laveti; their membership interest in Aditya will cease when Aditya is dissolved.
6. All of the assets of Aditya, both real property and personal property, will become the assets of Laveti.
7. The value of the of the stock of Laveti will be increased by the value of the assets of Aditya, and the membership interests of Aditya will cease to exist.
8. The only known pre-merger liability of Aditya is a joint and several liability of Laveti; therefore the liability of Laveti will not increase.
9. Laveti will assume any and all unknown liabilities of Aditya, should any become known.
10. No cash will be paid by either party to this merger to the other, nor to any shareholder or member.
11. Other than the property of Aditya being owned by Laveti after the merger, neither party to this merger will give any property to the other party nor to any stockholder or member.

12. This Plan of Merger does not require any changes to the Articles of Incorporation of Laveti, nor to Laveti's By-Laws.

13. This Plan of Merger shall be approved by the directors and stockholders of Laveti, and by the Manager and Members of Aditya, on or before September 5, 2019.

14. Provided that this Plan of Merger has been approved as hereinabove provided, Articles of Merger shall be filed with the Secretary of State of the State of Florida. Said Articles of Merger shall be effective on September 15, 2019 at 12:01 A.M., Eastern Standard Time.
