ARTICLE I - NAME

The name of this corporation is ELENA VORONKOVA, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence.



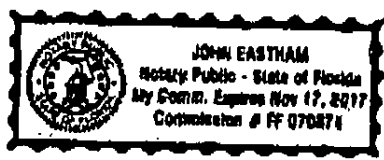
