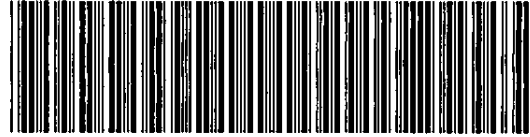

ARTICLE I
Name of Corporation

The name of this corporation is CLEEFY-ONE TRUCKING INC.

ARTICLE II
Purpose

Incorporated primarily as a provider of transportation services, CLEEFY-ONE TRUCKING INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III
Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV
Corporate existence and Date of Operation

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.

The directors shall hold office for the first year of existence of the corporation and until their successors are elected or appointed according to the by-laws.
