ARTICLE I. NAME

The name of this corporation is RETIRE SAFE FLORIDA, INC.

The term of existence of the corporation is perpetual.



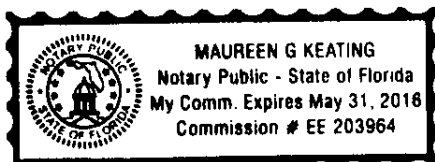


