ARTICLE I

Name and Duration

The name of the Corporation is Atlantic Coast Financial Investments, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

ARTICLE III

Registered Office and Agent
