## ARTICLES OF INCORPORATION

OF

## JORGE ALBERTO CEVALLOS, P.A.

The undersigned subscriber to these Articles of incorporation, is a natural person competent to contract, hereby associate themselves together to form a professional association under the Laws of the State of Florida providing for the formation of a corporation for profit with the powers, rights, privileges, and immunities hereinafter mentioned, and they hereby make, subscribe, and acknowledge and file with the Secretary of State of the State of Florida this Certificate of Incorporation; and to that end they do, by this Certificate, set forth the following Articles of Incorporation.

#### ARTICLE I

The name of this Professional association shall be: JORGE ALBERTO CEVALLOS, P.A.

## ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on are directed to the profession of real estate and to do any and all things allowed and permitted to be done by professional association under the Statutes of the State of Florida, and to do any and all the things hereinafter mentioned, as fully and to the same extend as natural persons might or could do, it wit:

- a.
