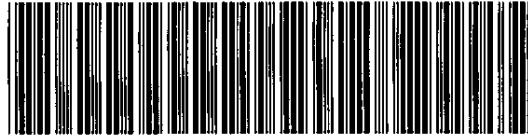

ARTICLES I – NAME
