**ARTICLE II**  
**CAPITAL STOCK**

The maximum number of shares of capital stock authorized to be issued by this corporation shall be **ONE HUNDRED SHARES** of common stock with no par value.

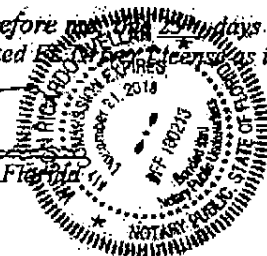
