In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is "17355689, Inc."

ARTICLE II

The existence of the Corporation shall begin on the date of filing these Articles with the Florida Department of State.

ARTICLE III

The street address of the principal office of the Corporation is 1662 Cross Tee Court, Oldsmar, Florida 34677.

ARTICLE IV

The general nature of the business to be transacted by this corporation and the objects and purposes of it is to conduct ALL LAWFUL BUSINESS.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 100 shares with a par value of \$.01 per share, all of which will be Common Shares. All Common Shares will be identical with each other in every respect, and the holders of Common Shares will be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

Any transfer of ownership of shares of stock in the corporation must be approved in writing by the holders of a majority of the outstanding voting stock. Prior to selling or transferring any shares of stock, shareholders seeking to sell or transfer shares must first offer to sell the shares back to the corporation for a price that is determined by the lower of (a) the fair market value of the shares seeking to be sold, or (b), the price the shareholder originally paid for the shares, plus 4% interest per year for each year the shareholder owned the shares.

ARTICLE VII

The name and address of the Corporation's registered agent is Lee H. Massey, 1021 Massachusetts Avenue, St. Cloud, Florida 34769.

ARTICLE VIII

The initial board of directors shall consist of one member. This number may be changed from time to time in accordance with the Corporation's bylaws, but it shall never be less than one. The name and address of the person who will serve on the initial board of directors is Bruce Jewer, 1662 Cross Tee Court, Oldsmar, Florida 34677.

ARTICLE IX

The name and street address of the Incorporator is Bruce Jewer, 1662 Cross Tee Court, Oldsmar, Florida 34677.

ARTICLE X

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE XI

These Articles of Incorporation may be amended at any time by a vote of the majority of the outstanding voting stock of any regular meeting of the stockholders, or at any special meeting of the stockholders called for that purpose.
