**ARTICLES OF INCORPORATION  
OF  
FIRST LANDINGS AVIATION & PILOTS, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
Name**

The name of the corporation is FIRST LANDINGS AVIATION & PILOTS, INC.

**ARTICLE II  
Purpose**

The corporation is formed for the purpose of conducting any lawful business.

**ARTICLE III  
Stock**

The corporation is authorized to issue stock as follows:

- (a) One million (1,000,000) shares of Class "A" common stock at One Dollar (\$1.00) per share par value, which shall have unlimited voting rights. The holders of the Class "A" shares shall be entitled to receive the net assets of the corporation upon dissolution and shall be responsible for the management of the corporation in accordance with Article V of these Articles.
- (b) One hundred million (100,000,000) shares of Class "B" common stock at Fifty Cents (\$.50) per share par value with no voting rights. The holders of the Class "B" shares shall not have management rights or responsibilities and shall not receive any assets of the corporation upon dissolution. The Class "B" shares shall be allotted to

corporate employees for the purpose of determining discretionary bonuses based on position and seniority as determined by the managing shareholders. Bonuses paid to Class "B" shareholders shall never exceed 15% of the corporation's annual net profit, and shall not be paid for at least the first three years of the corporation's existence.

**ARTICLE IV**  
**Registered Office and Agent**

The initial address of the principal and registered office of the corporation is 1321 Apopka Airport Road FBO, Apopka, Florida 32712.

The name of the corporation's registered agent at said address is Adam Valencic.

**ARTICLE V**  
**Management of Corporation by Shareholders**

All corporate powers will be exercised by or under the authority of, and the business of the corporation will be managed by the shareholders rather than a Board of Directors, including the power to adopt, alter, amend, or repeal By-Laws.

**ARTICLE VI**  
**Effective Date**

The corporation will commence existence on the date of filing these Articles of Incorporation.

**ARTICLE VII**  
**Incorporator**

Following is the name and street address of the person signing these Articles as incorporator:

**ARTICLE VIII**  
**Stockholders as Employees**

There shall be no policy prohibiting stockholders from serving as corporate officers or employees. In the event that a stockholder is employed by the corporation, said stockholder shall be entitled to receive a reasonable salary for services rendered.


**ARTICLE IX**  
**Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE X**  
**Amendment**

This corporation may amend its certificate of incorporation in any respect, provided that only such provisions shall be inserted by amendment as would be lawful and proper in an original certificate of incorporation made at the time of making such amendment. Every amendment shall be proposed by a stockholder and approved at a stockholders' meeting by not less than a majority of the stock entitled to vote thereon.




